Overview of the Cayman Crown Reef: A critical biodiversity hotspot and home to important Fish Spawning Aggregations (FSAs) such as Nicholas Caye, Seals Caye and Rise and Fall Bank



Challenge: Overfishing threatens the sustainability of FSAs, impacting fish populations and livelihoods.



Objective: Promote sustainable alternatives to reduce fishing pressure and diversify income sources.



Focus Areas:

- Seaweed Farming
- Coastal and Marine-Based Products and Services (Tour Guiding, Birding, and Restaurant Initiatives)


Results


FEASIBILITY STUDIES ON SEAWEED FARMING IN SAPODILLA CAYE MARINE RESERVE

- 3 communities (Punta Gorda Town, Monkey River and Placencia Village
- The Nature Conservancy conducted site inspection for test plots in SCMR in July 2024



FEASIBILITY STUDY

- TNC is lending technical support
- Rangers will undergo training in maintenance
- Biologist will be monitoring growth etc.



COASTAL AND MARINE TOURISM BASED PRODUCTS/SERVICES

Tour Guide Training

- •Rationale: Shift from extractive practices (fishing) to eco-tourism.
- •Training Focus:
- •Marine conservation and sustainable tourism.
- •Customer service and guiding techniques.
- •Outcome: Creation of certified tour guides leading sustainable tours of the Cayman Crown Reef and Sapodilla Cayes Marine Reserve e.g. Seaweed Farm Tours



BIRDING TRAINING

•Why Birding?

- Birdwatching is a growing eco-tourism niche.
- The Cayes and surrounding coasts attract many migratory species.

•Training Includes:

- Bird identification and environmental education.
- Proper use of birding equipment and guest engagement.
- •Outcome: Establishment of local birding guides, promoting ecotourism while raising awareness about conservation.



RESTAURANT INITIATIVE FOR WOMEN'S GROUP IN PUNTA NEGRA

Restaurant Initiative for Women's Group in Punta Negra

- Goal: Empower women through sustainable business ventures.
- Support Provided:
 - Business planning, branding, and food preparation training.
 - \ Assistance with sourcing ingredients and equipment.
 - Promotion of traditional Belizean cuisine to tourists.

\ Impact:

- Women-led restaurant contributes to household income and economic development.
- Strengthens community cohesion and promotes gender equality.



Benefits and Impact of Income Diversification

Economic Impact:

Diversified income streams reduce community reliance on fishing.

New tourism-based jobs boost household income.

Social Impact:

Strengthened local communities with new skill sets.

Empowerment of women and youth // through participation in the economy.

Environmental Impact:

Lower fishing pressure helps protect FSAs and marine biodiversity.

Eco-tourism fosters environmental stewardship in the community.



Success Stories and Case Studies

- •Example 1: Seaweed project in Belize showing potential resulting in:
- •MAIN SEAWEED PRODUCTS IN BELIZE.
- Packaged Raw Seaweed (wet and dry) sold either as wholesale or retail.
- Seaweed Beverages- unflavored, flavored (nutmeg, vanilla, honey, raisins, and peanuts) to name a few.
- Seaweed Ice cream- flavored and unflavored.
- Seaweed Dishes- salads, sushi dishes, porridge or risotto (rice cooked in a meat, fish or vegetable broth to a creamy texture).
- Processed Seaweed Gel- to tone the skin; to reduce wrinkles; to use as a detoxifier and as blends for aromatherapy for the muscles and joints.
- Seaweed spa and beauty products (for hair and skin)
- •Example 2: Punta Negra Women's Group restaurant attracts tourists, generating income and preserving cultural heritage.
- •Example 3: Trained tour guides successfully lead birdwatching tours, expanding ecotourism opportunities.

- •Summary: Income diversification strategies, such as seaweed farming and eco-tourism, are key to protecting FSAs while empowering communities.
- •Call to Action: Encourage stakeholders to support these initiatives and participate in sustainable development efforts.
